

Join the Early Adopter Pilot - What?

Hospitals

Real time access to a 180-day line of credit to fund their transactions, from an effective rate of interest of 0% to 8% per 180 day cycle.

bHoH compute-intelligence

Claims are ingested, marked-up, submitted, and reviewed and re-submitted.

Not a primary claim/billing service.

Patients

who are unable, unwilling, or otherwise rejected for their obligation are eligible to participate in Novum Care Plans and access Hastat Money.

NoviRx and NovaGenome

Access prescriptions, OTCs, and other healthcare related supplies with up to 100% offset.




